

Privacy Collection Statement

This policy covers how Brookwater Golf and Country Club treats Personal Information that it collects and

receives, including information relating to your past use of Brookwater Golf and Country Club products and

services. Personal Information is information about you that is personally identifiable like your name, address, email address or phone number, and which is not otherwise publicly available.

General

Brookwater Golf and Country Club collects Personal Information when you register with Brookwater Golf and Country Club,

when you use Brookwater Golf and Country Club products or services, when you visit Brookwater Golf and Country Club

Internet pages or the Internet pages of certain Brookwater Golf Club partners (including Troon Golf), and when you enter promotions or sweepstakes.

For what purpose does Brookwater Golf and Country Club require your Personal Information

Brookwater Golf and Country Club collects and uses the Personal Information about you primarily to give you golf

course updates and to provide you with information about upcoming events and special offers.

Brookwater Golf and Country Club also uses the Personal Information for related (or secondary) purposes

including:

1. To customise the advertising and content of our Internet pages, fulfil your requests for products and services, improve our services, conduct research and provide anonymous reporting for internal and external clients;
2. To provide you with marketing materials, such as market data and newsletters;
3. To provide you with information about current and upcoming promotions;
4. To advise you of the products and services offered by Brookwater Golf and Country Club and its related

companies including Troon Golf and Springfield Land Corporation.

How Brookwater Golf and Country Club may use your Personal Information

Brookwater Golf and Country Club may disclose Personal Information about you (for the purposes set out above)

to:

1. Any of its related companies (and their joint venture partners); and
2. Springfield Land Corporation and any of its related companies (and their joint venture partners).

Your right to access your records

You may request access to the Personal Information which Brookwater Golf and Country Club holds about you,

and Brookwater Golf and Country Club will grant you such access unless it is required or permitted to refuse such

a request. You may also request that your Personal Information be corrected if you think that it is not accurate.

When and how you can opt out

If you no longer wish to receive any communications from Brookwater Golf and Country Club relating to the

purposes set out above, you may at any time contact Brookwater Golf and Country Club to request not to receive

any such communications (you may "opt out"). If you make an opt-out request, Brookwater Golf and Country Club will action this request as soon as reasonably practicable.
